Transponders – The FAA has put in place a program for requiring transponders be put into all flying model aircraft. The AMA is trying to get exclusions for AMA Sanctioned Fields. This all takes effect on 16 Sept 2023. More updates as to how this effects us as more info becomes available. In the meantime here's an AMA PDF File as to what's happened so far. In addition the FAA has required all model aircraft fliers to be registered. It's a pretty simple process and it costs 5 dollars. You will be given an FAA number to be displayed on your models also. We highly recommend that everyone gets this. This has already been put into law and has been in effect for a couple of years now. A hefty fine can be levied on someone who doesn't comply.
