**Officer Election – Will be on the 15<sup>th</sup> of April on Saturday during the Club Meeting held at 1:00PM at the field. Everyone is encouraged to participate or nominate any one as an Officer for the Club.**

**Mower Maintenance – Batteries were removed and charged. One of the wheel spindles also needed repair. They should be in good shape to start the season.**

**Mower Shed – The enclosure (corn crib) covering our shed has had a partial collapse on the section opposite of our shed. No damage has occurred to the shed. We don't have any details on whether Padre Pio will be taking this down but they said they would inform us of any plans. The idea is to keep the mower shed intact.**

**Field Rolling – We all agreed to roll the field again this season. We will decide in April when the best time would be to accomplish this task based on the weather at that time.**

**FRIA Submission – We have applied for our field to be a FAA-Recognized Identification Area. We will keep you all posted on the details as they become available. This will eliminate the requirement of using a remote ID when using the field. Implementation date is slated for 16 Sept 23.**

**Flying Zones – Lets continue to police ourselves and to abide by our Flying Rules and Regulations. We haven't had any recent issues and many thanks go out to everyone. We have a great relationship with our hosts at Padre Pio.**

**Access Road to Field – Needs to be filled in with stone and leveled out to remove the ruts and mud patches. Padre Pio will be getting back to us on some stone. We will try to get this filled in and taken care of shortly.**

**Weekend and Weekday Meetings - We will be alternating between Wednesdays and Saturdays for our Club Meetings. This seasons schedule can be found on the calendar section of the Web Site.**

**New Membership Form – We have had several members who didn't include the signed Flying Rules Agreement. Please ensure you include this with your submission to obtain your Club Membership.**

**Padre Pio had recently asked us to get some drone footage of all the roof sections for the facility. There had been several recent storm events and wind events and they were worried about roof damage. There were several members that stepped up to the plate and volunteered.
